In prior years, several grants were incorrectly reported as excess contributions.

A one-time grant of \$30,000 in 2010 should have been categorized as an unusual grant. The total dollar contributions reported for 2010 therefore should be \$47,648 less \$30,000 = \$17,648. This has been corrected on the 2012 990EZ Schedule A, Part II.

Grants of \$5,000 per year since 2004 from a governmental agency are not required to be included as excess contributions.

Therefore, there have been no excess contributions to date for the organization. The 2012 990EZ, Schedule A reflects these corrections, with 0 dollars reported on line 5(f). As a result, line 14, the public support percentage, is increased to 98.73% in 2012.

The Oregon Green School Summit is one of the highlights of our program. Each year, students and staff from participating Green Schools and Green Schools coordinators gather for a full day of celebration, learning and networking.

The 2012 Oregon Green Schools Summit had 350 people attending, representing 47 schools from 18 different cities across Oregon.

During 2012 there were 245 participating Green Schools, of which 80 were either new or renewing, and 23 participating Green Schools Coordinators.

For the Summit, each Green School is invited to send a team of students and one adult to participate at no charge. The event is a fun, enriching opportunity to celebrate successes, gain new skills, generate enthusiasm,

and share ideas with peers from across Oregon. The day also includes a showcase of green school programs in the exhibit hall. Each school brings a display to demonstrate the achievements of its resource efficiency program or showcase a specific topic.

The Summit is a powerful opportunity for students to see how their efforts are magnified by the efforts of students at other schools. By the end of the day, everyone returns home with a broader sense of community and renewed enthusiasm.

In 2012, student teams from Oregon Green Schools Association (OGSA) certified schools met on April 9 at the 16th annual OGSA Summit in Eugene for a full day of learning from school displays, networking, performing arts and hands-on activities.

Elementary and middle school students attended three educational sessions on a wide variety of topics and the Green School Showcase, which featured student presentations from three premier level schools, was extremely popular. Sessions for high school students included an opportunity to meet with University of Oregon students to learn about how high school students can become more involved within their schools and beyond. High school students also enjoyed a tour of the Next Step e-waste recycling operation in Eugene where they got to learn about the challenges and opportunities of recycling electronics. Adults were free to attend any workshop. Two popular sessions, OGSA 101 - Stepping Up Your Program, and the Adult Roundtable, were packed to capacity with teachers, custodians, administrators and others involved with school environmental efforts.

Students learned how to make worm bins and do a waste audit, how to use recycled materials to make art and crafts. They took the walk and bike challenge. They learned what students all over the country were doing to alert our elected officials about the effects of climate change.

The Summit worked hard to put on "waste free" meals, and by providing food in bulk, collecting leftovers and milk/juice containers for composting, bringing waste-free lunches and observing a "Pack it in, Pack it out" policy whereby they took home any garbage they had brought with them, only one small bag of compostable garbage was created during the entire event. The "Edu-tainment" portion of the summit included a "trashion" show where students modeled outfits made from recyclables and used materials. The Summit finale was an open mic session whereby students of all ages were invited to come to the front stage and briefly share what they are doing at their school. Approximately 40 students were brave enough to come speak to the entire audience. It was a wonderful closure to a beautiful day and students left feeling engaged and energized!
